A motion to approve **resolution 2010-10** which is for the approval for the City Clerk to prepay recurring bills to avoid service charges was made by Jebesen with a second by Simmons. All ayes.

**Resolution 2010-11** which is for setting wages for the 2011 fiscal year was tabled.

The remainder of the meeting was used for budgeting for the 2011 fiscal year.

At 8:10 p.m. a motion to adjourn was made by Simmons with a second by Goodall. All ayes.
