

**Delmar City Council Proceedings**  
**January 11, 2017**

Mayor Hardin called the regular meeting of the Delmar City Council to order at 6:00 p.m. with council members Eberhart, Simmons, Goodall, Frett and Jebesen present. Also present were city employees Paul Ruchotzke and Jerry Nigh.

The **consent agenda** included the minutes of the December 14<sup>th</sup> meeting, Clerk's financial report and the following revenues and expenses:

A motion to approve **resolution 2017-08** which is for allowing the City Clerk to pay bills prior to a meeting to avoid late charges was made by Frett with a second by Simmons. All ayes.

A motion to approve **resolution 2017-09** which is for designating the Maquoketa Sentinel Press as the newspaper for the City's publications was made by Eberhart with a second by Goodall. All ayes.

A motion approve **resolution 2017-10** which is for designating Clinton National Bank as the City's depository was made by Frett with a second by Simmons. Ayes – Frett, Simmons, Goodall, Eberhart. Abstain – Jebesen.

The **Clinton County Sheriff's Office** spent 63.38 hours in the City of Delmar between November 26, 2016 through December 25, 2017 while on patrol they handled 1 incident and answered 4 calls.

Reports – viaduct wall needs attention, discussed old buildings snow removal & grass mowing. Discussed the need for new doors at the maintenance shed.
