

**Delmar City Council Proceedings  
March 8, 2017**

Mayor Hardin called the regular meeting of the Delmar City Council to order at 6:00 p.m. with council members Simmons, Eberhart, Frett, Goodall and Jebson present. Also present were city employees Paul Ruchotzke, Jerry Nigh, Terry Behn and Laurie Ganzer.

The **consent agenda** included the minutes of the February 8<sup>th</sup> meeting, Clerk's financial report and the following revenues and expenses:

No oral or written comments were made.

At 6:04 p.m. a motion to close the public hearing for the 2018 Budget was made by Eberhart with a second by Simmons. All ayes.

A motion to approve **resolution 2017 – 11** which is for the approval of the 2018 Budget was made by Frett with a second by Jebson. All ayes.

A motion to approve 2 grills be put in the park was made by Simmons with a second by Frett. Ayes – Eberhart, Goodall, Simmons, Frett. Abstain – Jebson.

A motion to approve the purchase of an overhead door for the maintenance shed at a cost of \$1,670.00 and a salt spreader at a cost of \$4,950.45 was made by Eberhart with a second by Frett. All ayes.

A motion to approve ditch work in various locations by JJJ Enterprises in the amount of \$2,615.00 was made by Goodall with a second by Simmons. All ayes.

**Spring Clean up** will be scheduled for May 19<sup>th</sup> and 20<sup>th</sup>.

A motion to approve the 1<sup>st</sup> reading of **ordinance 113-17** which is for setting the rate for snow removal on private properties by city employees to \$150.00 per occurrence was made by Eberhart with a second by Frett. All ayes.

Ganzer will contact the city attorney to write an **ordinance prohibiting the use of bows and cross bows** in the city limits.

The **Clinton County Sheriff's Office** spent 57.45 hours in the city of Delmar from January 26, 2017 through February 25, 2017 while on patrol they issued 2 warnings, 1 citation, handled 1 incident and answered 2 calls.
