A motion to approve the consent agenda was made by Goodall with a second by Jebsen. All ayes.

The Clinton County Sheriff's Office spent 74.42 hours in the City of Delmar between April 26, 2010 and May 25, 2010 while on patrol they issued 1 warning, handled 5 incidents and answered 6 calls.

No comments were made during public forum.

A motion to approve **building permit 227** for 607 Hurst Street was made by Jebsen with a second by Goodall. All ayes.

Water pressure at 101 Richland Street was discussed. A bid from Joel Woods Plumbing for \$1,502.00 to install a pressure booster and an air release tank was submitted. Ruchotzke will check pressure at surrounding residents before further action is taken.

A motion to approve the bid from JJJ Enterprises for \$550.83 to tile the city portion of the area around 601 Sparks Street was made by Goodall with a second by Simmons. All ayes. The property owner of 601 Sparks Street will be responsible for an additional \$190.66 for the portion that will be tiled on their property.

A motion to approve up to \$20,000.00 in street repairs by Municipal Street Improvements was made by Goodall with a second by Simmons. All ayes. Ruchotzke will contact MSI for a bid on various areas in town and will make a determination on repairs based on need. Ruchotzke will have as many areas as possible repaired with the funds available.

During **reports** Ruchotzke reminded everyone that the water tower will be cleaned on June 22nd.

Simmons stated that the Lion's will be taking over the car show this year.

Roof repairs for the Depot were discussed. LouAnn Eberhart brought a donation of \$196.05 from the food stand at the estate sale on June 6th to put in the fund for the roof repairs. Applying for a grant to help with the cost of the project was discussed. The following items were tabled:
