Ganzer was instructed to draft a letter to property owners at 101 Richland Street regarding adequate water pressure to mains and include a copy of the City's water ordinance.

Ganzer was instructed to submit the bid from Charlotte Electric to the insurance company for the flashing light repair.

Golf Cart Ordinance was tabled.

Repairs to fire station were tabled.

A motion to approve a bid for \$18,596.70 with Municipal Streets Improvements was made by Jebson with a second by Simmons. All ayes.

During reports Ganzer noted that the Patricia Powers family has donated \$1,000.00 to the Depot roof replacement fund.

ECIA has notified the city that volunteers are needed to fill the Eastern Iowa Regional Authority Board seats.

A motion to adjourn at 7:35 p.m. was made by Goodall with a second by Jebson. All ayes.
