Delmar City Council Proceedings October 8, 2014

A motion to increase the **insurance for the contents of the Depot** from \$10,800.00 to 30,000.00 at a cost of approximately \$300.00 annually was made by Henderson with a second by Frett. All ayes.

A motion to approve **resolution 2015-05** which is for transferring funds from water savings in the amount of \$52,000.00 to cover cost of new water meters and from vehicle savings in the amount of \$17,800.00 to cover cost of 1999 Ford purchase to checking was made by Goodall with a second by Frett. All ayes.

A motion to change the date of the **hearing for the abatement at 614 Main** to November 12th at 6:00 p.m. was made by Henderson with a second by Frett. All ayes.

A motion to approve building material costs for putting a **fence around a city drain** on property owned by Pam & Loras Frost with Mr. Frost providing the labor was made by Henderson with a second by Goodall. All ayes. Generator for sewer plant was tabled.

The **Clinton County Sheriff's Office** spent 59.08 hours in the city of Delmar from August 25, 2014 through September 25, 2014 while on patrol they handled 2 incidents and answered 3 calls.

Reports – camera prices for the park will be brought to the next council meeting. Continuous vandalism at the park will not be tolerated in the future and all persons caught will be prosecuted by the City.

A motion to adjourn at 7:00 p.m. was made by Jebsen with a second by Henderson. All ayes.
