

Delmar City Council Proceedings
October 12, 2016

Mayor Hardin called the regular meeting of the Delmar City Council to order at 6:00 p.m. with council members Eberhart, Goodall, Frett, Jebesen and Simmons present. Also present were city employees Laurie Ganzer, Paul Ruchotzke, Jerry Nigh and Terry Behn.

The **consent agenda** included the minutes of the September 14th meeting, Clerk's financial report and the following revenues and expenses:

A motion to approve the **storage extension on the fire station** was made by Simmons with a second by Eberhart. Ayes – Jebesen, Goodall, Simmons and Eberhart. Abstain – Frett.

A motion to approve **resolution 2017-04** which is for the approval of the 2016 Annual Financial report was made by Jebesen with a second by Frett. All ayes.

A motion to approve **resolution 2017-05** which is for setting the public hearing date for the adoption of the City Code of Ordinances was made by Eberhart with a second by Simmons. All ayes.

Mayor Hardin discussed the vulnerability and assessment plan for the City's water system.

A motion to put 2 grills in the park was made by Simmons with a second by Goodall. All ayes.

Mayor Hardin read a proclamation declaring **October Breast Cancer Awareness month**.

Ganzer was instructed to prepare a resolution for the Iowa Home Base program.

The **Clinton County Sheriff's Office** spent 61.92 hours in the City of Delmar from August 26, 2016 through September 25, 2016 while on patrol they issued 4 warnings, 5 citations, handled 3 incidents and answered 12 calls.
